**Purpose.** The 5-Year and Annual PHA Plans provide a ready source for interested parties to locate basic PHA policies, rules, and requirements concerning the PHA's operations, programs, and services, including changes to these policies, and informs HUD, families served by the PHA, and members of the public of the PHA's mission, goals and objectives for serving the needs of low- income, very low- income, and extremely low- income families

**Applicability.** The Form HUD-50075-HP is to be completed annually by **High Performing PHAs**. PHAs that meet the definition of a Standard PHA, Troubled PHA, HCV-Only PHA, Small PHA, or Qualified PHA do not need to submit this form.

# Definitions.

- (1) High-Performer PHA A PHA that owns or manages more than 550 combined public housing units and housing choice vouchers and was designated as a high performer on both the most recent Public Housing Assessment System (PHAS) and Section Eight Management Assessment Program (SEMAP) assessments.
- (2) Small PHA A PHA that is not designated as PHAS or SEMAP troubled, and that owns or manages less than 250 public housing units and any number of vouchers where the total combined units exceed 550.
- (3) Housing Choice Voucher (HCV) Only PHA A PHA that administers more than 550 HCVs, was not designated as troubled in its most recent SEMAP assessment and does not own or manage public housing.
- (4) Standard PHA A PHA that owns or manages 250 or more public housing units and any number of vouchers where the total combined units exceed 550, and that was designated as a standard performer in the most recent PHAS or SEMAP assessments.
- (5) Troubled PHA A PHA that achieves an overall PHAS or SEMAP score of less than 60 percent.
- (6) Qualified PHA A PHA with 550 or fewer public housing dwelling units and/or housing choice vouchers combined and is not PHAS or SEMAP troubled

The Quincy Housing Authority's Section 8 Administrative Plan was amended to reflect this administrative change. Dedham Housing Authority currently oversees the voucher program administration and has been notified of this change. This amendment is in effective for this year's annual plan. The Holbrook Housing Authority entered into a management agreement with the Quincy Housing Authority in February 2023 for a contract term of 1-year and 4 months, expiring June 2024. The Holbrook Housing Authority anticipates extending the management agreement for another contract term, pending Board approval.</li> <li>The Holbrook Housing Authority's Leased Housing programs are currently administered by Dedham Housing Authority. This management agreement is in place until 2026. Upon termination of the agreement with the Dedham Housing Authority, the HHA's HCVP program will be managed by the Quincy Housing Authority and will adhere to the QHA's Administrative Plan except for Waiting List local preferences.</li> <li>Holbrook Housing Authority's inspections are currently being performed under the management agreement with Quincy Housing Authority. Quincy Housing Authority has switched from using HQS as the standard inspection system to INSPIRE, and also adheres to the Massachusetts State Sanitary code for all inspections.</li> <li>The Holbrook Housing Authority and thorities are committed to furthering fair housing. The Holbrook Housing Authority's voucher program is currently administered by Dedham Housing Authority and practices for creating greater access to opportunities are governed by the Dedham Housing Authority's Section 8 Administrative Plan and utilizes a language access plan. Dedham Housing Authority's current voucher-holder portfolio provides subsidized assistance to approximately 8% for Hispanic families, which is 5% higher than the national average for the town of Holbrook. Furthermore, under Section 5A(d)(15) of the U.S. Housing Act of 1937, as amended, a PHA must submit a civil rights certification with its Annual PHA Plan, which is described at 24 CFR 903.7(o)(1) except for qualified PHAs who submit the Form HUD-50077-CR as a standalone document.

This information collection is authorized by Section 511 of the Quality Housing and Work Responsibility Act, which added a new section 5A to the U.S. Housing Act of 1937, as amended, which introduced the 5-Year and Annual PHA Plan. The 5-Year and Annual PHA Plans provide a ready source for interested parties to locate basic PHA policies, rules, and requirements concerning the PHA's operations, programs, and services, and informs HUD, families served by the PHA, and members of the public of the PHA's mission, goals and objectives for serving the needs of low-income, very low-income, and extremely low-income families.

Public reporting burden for this information collection is estimated to average 7.02 hours per response, including the time for reviewing instructions, searching existing data sources, gathering and maintaining the data needed, and completing and reviewing the collection of information. HUD may not collect this information, and respondents are not required to complete this form, unless it displays a currently valid OMB Control Number.
