Purpose. The 5-Year and Annual PHA Plans provide a ready source for interested parties to locate basic PHA policies, rules, and requirements concerning the PHA’s operations, programs, and services, including changes to these policies, and informs HUD, families served by the PHA, and members of the public of the PHA’s mission, goals and objectives for serving the needs of low- income, very low- income, and extremely low- income families

Applicability. The Form HUD-50075-HP is to be completed annually by **High Performing PHAs**. PHAs that meet the definition of a Standard PHA, Troubled PHA, HCV-Only PHA, Small PHA, or Qualified PHA do not need to submit this form.

Definitions.

- (1) **High-Performer PHA** – A PHA that owns or manages more than 550 combined public housing units and housing choice vouchers and was designated as a high performer on both the most recent Public Housing Assessment System (PHAS) and Section Eight Management Assessment Program (SEMAP) assessments.
- (2) **Small PHA** - A PHA that is not designated as PHAS or SEMAP troubled, and that owns or manages less than 250 public housing units and any number of vouchers where the total combined units exceed 550.
- (3) **Housing Choice Voucher (HCV) Only PHA** - A PHA that administers more than 550 HCVs, was not designated as troubled in its most recent SEMAP assessment and does not own or manage public housing.
- (4) **Standard PHA** - A PHA that owns or manages 250 or more public housing units and any number of vouchers where the total combined units exceed 550, and that was designated as a standard performer in the most recent PHAS or SEMAP assessments.
- (5) **Troubled PHA** - A PHA that achieves an overall PHAS or SEMAP score of less than 60 percent.
- (6) **Qualified PHA** - A PHA with 550 or fewer public housing dwelling units and/or housing choice vouchers combined and is not PHAS or SEMAP troubled.

The Holbrook Board of Commissioners seeking to remedy this disparity authorized the Executive Director to remove the local preference that may be contributing to a disparate impact on Hispanic families. The Quincy Housing Authority's Section 8 Administrative Plan was amended to reflect this administrative change. Dedham Housing Authority currently oversees the voucher program administration and has been notified of this change. The Holbrook Housing Authority entered into a management agreement with the Quincy Housing Authority in February 2023 for a contract term of 1-year and 4 months, expiring June 2024. The Holbrook Housing Authority anticipates extending the management agreement for another contract term, pending Board approval. • The Holbrook Housing Authority’s Leased Housing programs are currently administered by Dedham Housing Authority. This management agreement is in place until 2026. Upon termination of the agreement with the Dedham Housing Authority, the HHA’s HCVP program will be managed by the Quincy Housing Authority and will adhere to the QHA’s Administrative Plan except for Waiting List local preferences. • Holbrook Housing Authority’s inspections are currently being performed under the management agreement with Quincy Housing Authority. Quincy Housing Authority has switched from using HQS as the standard inspection system to INSPIRE, and also adheres to the Massachusetts State Sanitary code for all inspections. • The Holbrook and Dedham Housing Authorities are committed to furthering fair housing. The Holbrook Housing Authority’s voucher program is currently administered by Dedham Housing Authority and practices for creating greater access to opportunities are governed by the Dedham Housing Authority’s Section 8 Administrative Plan and utilizes a language access plan. Dedham Housing Authority’s current voucher-holder portfolio provides subsidized assistance to approximately 8% for Hispanic families, which is 5% higher than the national average for the town of Holbrook. This comprises approximately 50% of families identifying as non-hispanic. The largest population based on age is 25-59 years of age, with approximately 26% of families listing a member of the household with a disability. Holbrook Housing Authority is defined as a community with less than 5% of the community living below the poverty line. Dedham Housing Authority uses a combination of in-person and digital outreach services to ensure equal access to all families. See administrative plans for all fair housing initiatives taken by Dedham Housing Authority: https://dedhamhousing.org/Policies_and_Plans.php. The Holbrook Housing Authority employs the same practices as the Dedham Housing Authority according to Quincy Housing Authority’s Language Access and administrative plans. The Holbrook Housing Authority in concert with Dedham Housing Authority will continue to review practices and demographic data annually to ensure the needs of the population of the community are being met. <p>In 2024, Holbrook Housing Authority centralized maintenance functions, and established internal controls for time management for employees of the agency. In addition, a lockbox system was created for tenant rental payments. A disparity was identified in housing demographics among those Hispanic families on the waiting list and those housed under Holbrook Housing Authority. Based on a mandate from state legal counsel to remedy this disparity, the Holbrook Housing Authority Board of Commissioners removed the local preference. The housing choice voucher program is still being managed by Dedham Housing Authority, who has been made aware of this change.</p> <p>The Holbrook Housing Authority has not fully implemented all HOTMA legislative mandates as there is a delay due to software implementation.</p>

C.3 Civil Rights Certification/ Certification Listing Policies and Programs that the PHA has Revised since Submission of its Last Annual Plan. Provide a certification that the following plan elements have been revised, provided to the RAB for comment before implementation, approved by the PHA board, and made available for review and inspection by the public. This requirement is satisfied by completing and submitting form HUD-50077 ST-HCV-HP, *PHA Certifications of Compliance with PHA Plan, Civil Rights, and Related Laws and Regulations Including PHA Plan Elements that Have Changed*. Form HUD-50077-ST-HCV-HP, *PHA Certifications of Compliance with PHA Plan, Civil Rights, and Related Laws and Regulations Including PHA Plan Elements that Have Changed* must be submitted by the PHA as an electronic attachment to the PHA Plan. This includes all certifications relating to Civil Rights and related regulations. A PHA will be considered in compliance with the certification requirement to affirmatively further fair housing if the PHA fulfills the requirements of §§ 903.7(o)(1) and 903.15(d) and: (i) examines its programs or proposed programs; (ii) identifies any fair housing issues and contributing factors within those programs, in accordance with 24 CFR 5.154; or 24 CFR 5.160(a)(3) as applicable (iii) specifies actions and strategies designed to address contributing factors, related fair housing issues, and goals in the applicable Assessment of Fair Housing consistent with 24 CFR 5.154 in a reasonable manner in view of the resources available; (iv) works with jurisdictions to implement any of the jurisdiction’s initiatives to affirmatively further fair housing that require the PHA’s involvement; (v) operates programs in a manner consistent with any applicable consolidated plan under 24 CFR part 91, and with any order or agreement, to comply with the authorities specified in paragraph (o)(1) of this section; (vi) complies with any contribution or consultation requirement with respect to any applicable AFH, in accordance with 24 CFR 5.150 through 5.180; (vii) maintains records reflecting these analyses, actions, and the results of these actions; and (viii) takes steps acceptable to HUD to remedy known fair housing or civil rights violations. impediments to fair housing choice within those programs; addresses those impediments in a reasonable fashion in view of the resources available; works with the local jurisdiction to implement any of the jurisdiction’s initiatives to affirmatively further fair housing; and assures that the annual plan is consistent with any applicable Consolidated Plan for its jurisdiction. ([24 CFR §903.7\(o\)](#)).

C.4 Challenged Elements. If any element of the Annual PHA Plan or 5-Year PHA Plan is challenged, a PHA must include such information as an attachment to the Annual PHA Plan or 5-Year PHA Plan with a description of any challenges to Plan elements, the source of the challenge, and the PHA’s response to the public.

D. Affirmatively Furthering Fair Housing.

D.1 Affirmatively Furthering Fair Housing.

The PHA will use the answer blocks in item D.1 to provide a statement of its strategies and actions to implement each fair housing goal outlined in its accepted Assessment of Fair Housing (AFH) consistent with 24 CFR § 5.154(d)(5) that states, in relevant part: “To implement goals and priorities in an AFH, strategies and actions shall be included in program participants’ ... PHA Plans (including any plans incorporated therein) ... Strategies and actions must affirmatively further fair housing” Use the chart provided to specify each fair housing goal from the PHA’s AFH for which the PHA is the responsible program participant – whether the AFH was prepared solely by the PHA, jointly with one or more other PHAs, or in collaboration with a state or local jurisdiction – and specify the fair housing strategies and actions to be implemented by the PHA during the period covered by this PHA Plan. If there are more than three fair housing goals, add answer blocks as necessary.

Until such time as the PHA is required to submit an AFH, the PHA will not have to complete section D., nevertheless , the PHA will address its obligation to affirmatively further fair housing by fulfilling the requirements at 24 CFR 903.7(o)(3) enacted prior to August 17, 2015, which means that it examines its own programs or proposed programs; identifies any impediments to fair housing choice within those programs; addresses those impediments in a reasonable fashion in view of the resources available; works with local jurisdictions to implement any of the jurisdiction’s initiatives to affirmatively further fair housing that require the PHA’s involvement; and maintain records reflecting these analyses and actions. Furthermore, under Section 5A(d)(15) of the U.S. Housing Act of 1937, as amended, a PHA must submit a civil rights certification with its Annual PHA Plan, which is described at 24 CFR 903.7(o)(1) except for qualified PHAs who submit the Form HUD-50077-CR as a standalone document.

This information collection is authorized by Section 511 of the Quality Housing and Work Responsibility Act, which added a new section 5A to the U.S. Housing Act of 1937, as amended, which introduced the 5-Year and Annual PHA Plan. The 5-Year and Annual PHA Plans provide a ready source for interested parties to locate basic PHA policies, rules, and requirements concerning the PHA's operations, programs, and services, and informs HUD, families served by the PHA, and members of the public of the PHA's mission, goals and objectives for serving the needs of low- income, very low- income, and extremely low- income families.

Public reporting burden for this information collection is estimated to average 7.02 hours per response, including the time for reviewing instructions, searching existing data sources, gathering and maintaining the data needed, and completing and reviewing the collection of information. HUD may not collect this information, and respondents are not required to complete this form, unless it displays a currently valid OMB Control Number.
